PROPOSED DISPOSAL OF SHAREHOLDING INTEREST IN INTRACO LIMITED BY HANWELL HOLDINGS LIMITED

1. The Board of Directors (the “**Board**”) of Intraco Limited (the “**Company**”) wishes to announce that the Company’s controlling shareholder, Hanwell Holdings Limited (“**HHL**”) has informed the Company that HHL has entered into a sale and purchase agreement (the “**Agreement**”) dated 13 September 2012 with TH Investments Pte Ltd (the “**Purchaser**”) to transfer its 29.87% shareholding interest in the issued share capital of the Company to the Purchaser (the “**Disposal**”).

2. HHL has made an announcement on 13 September 2012 in respect of the Disposal (the “**Announcement**”). A copy of the Announcement made by HHL is attached to this announcement.

3. **CAUTIONARY STATEMENT**

Shareholders and potential investors should note that the completion of the Disposal is conditional upon the approval from HHL’s shareholders in respect of the Disposal being obtained (if required), and are therefore advised to exercise caution when dealing or trading in the shares of the Company and refrain from taking any action in respect of their shares which may be prejudicial to their interests.

Shareholders and potential investors should consult their stockbrokers, bankers, solicitors or other professional advisers if they have any doubt about the actions they should take.

None of the Directors or controlling shareholders of the Company other than HHL has any interest, direct or indirect, in the Disposal.
