Ltd.

In connection with the above, the IL_D021_1A/SGD and IL_D015_1/USD, which was launched on 26 Aug 2025, under the SDAX CP Facility Programme, had matured on 30 Sep 2025.

Accordingly, the 218 Tokens (direct and deemed interest) in respect of the IL_D021_1A/SGD and IL_D015_1/USD issued on 26 Aug 2025 have been fully redeemed by the Company on 30 Sep 2025.
