Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D030_1A/SGD and IL_D023_1/USD, which was launched on 2 Jul 2026, under the SDAX CP Facility Programme, had matured on 14 Aug 2026.

Accordingly, the 639 Tokens (direct and deemed interest) in respect of the IL_D030_1A/SGD and IL_D023_1/USD issued on 2 Jul 2026 have been fully redeemed by the Company on 14 Aug 2026.
